A study, appraisal or review by the Board or its duly authorized representatives, of the quality of audit of financial statements through a review of the quality control measures instituted by an Individual CPA, Firm or Partnership of CPAs (henceforth collectively referred to as CPA Practitioners) engaged in the practice of public accountancy to ascertain his/her/its compliance with prescribed professional, ethical and technical standards of public practice.

- QAR Office has already been established and has conducted test **QAR** Inspections

PICPA AND ACPAPP HAVE BEEN CONDUCTING TRAININGS TO ADDRESS THE COMPLIANCE NEEDS OF PRACTITIONERS IS QAR **IMPLEMENTED ONLY IN THE PHILIPPINES**

- 2. in the US, PCAOB has been existing since 2002
- 3. in the UK, their QAR program has been established since the 1990s
- 4. in the ASEAN, even Cambodia and Vietnam have already implemented their respective QAR Program.


